#### **UWEC New Hibbard Parking Lot Sign (Jake Wrasse, UWEC)**

- Planning commission voted to let the sign proceed.
- Original motion in March had to be corrected it didn't have to go back to the planning commission or to city council.
- Installation subject to confirmation of contractor
- Next few months it will likely be installed
- Sign will be at a diagonal facing into the intersection, a little under 6' tall.
- Doesn't cast a light. Is contained, legible.

#### **September Third Ward Thrift Sale**

- We have signs out throughout the neighborhood
- Need more signs. The sale has been advertised in the newspaper, NextDoor.

#### **Eau Claire Marathon - Third Ward**

- Normally in May, moved to September
- They get volunteers
- The money taken in is divided between groups
- There is an opportunity to man different intersections

## **100 Years Old, Celebrating our Homes**

- Will happen probably in 2022
- Hoping to come up with three ideas to highlight living in an older neighborhood
- Considering a street, multiple homes, a block party, or houses turning 100 years
- Goal is to get more people in the neighborhood out looking at houses with a celebratory/party-like vibe
- Sharon has done annual house tours in the past.
- Suggestion of including the 150-year-old homes.

### **Parking App for McKinley Ave**

- New technology could enable us to monetize spaces in front of houses
- Those parking spots given away for free every day
- Money could be used for assessments for work on McKinley
- We could also be collecting money on the 17 spots on Garfield now vacated for the bike lanes

#### **Chippewa Valley Housing Recommendations**

- The stakeholders involved in this project did not include any neighborhood organizations
- Neighborhood organizations characterized as a roadblock to density
- Document aims to relax parking rules, one of our largest issues in the neighborhood
- Policies include identifying infill sites and redevelopment areas
- Document states goal of improving public engagement process, finding reasonable options
- Document discusses moving from use/density towards form-based standards what does this mean?
- Concern that neighborhoods are not being treated equally in this effort
- Are there grants being given to the city to increase infill and density?
- Scott Allen had pointed to the city council as the authority on zoning policy
