Parking App for McKinley Ave:

Kevin spoke and Todd from city staff was happy to attend and talk about parking app options. Kevin discussed how cars sit for more than time frame, and the issues with the road from damage being done.

Todd discussed the issues on the aspect of the city. The city plans to improve technology LPR system and have police onboard to have the equipment to recognize licenses plates. So far no luck implementing the neighborhood parking permit. Hoping that LPR system could change that for the future with the thought that so many for residents and the additional ones could be sold to the students.

Other neighborhoods have expressed interest such as Randall park, North High School, Memorial High School, Regis High school. Assessments would have to be discussed on how it affects properties.

Issue was brought up that work on houses are having issues, with contractors not able to park in front of the home site (Block Ally, or the Street the police department wasn't honoring spots for them instead are giving out citations).

Jake UWEC would like to be part of the LPR technology and wants to partner with to make sure that the neighborhood addresses the parking concerns.

Todd stated for future use please call the city and they will help guide the permit \$25 to use for construction remodeling site. Parking revenue to go to the general fund with the city.

Direct funding questions to city manager with the budget (Todd). No exact costs just a rough idea, for future parking issues at a pilot program.
